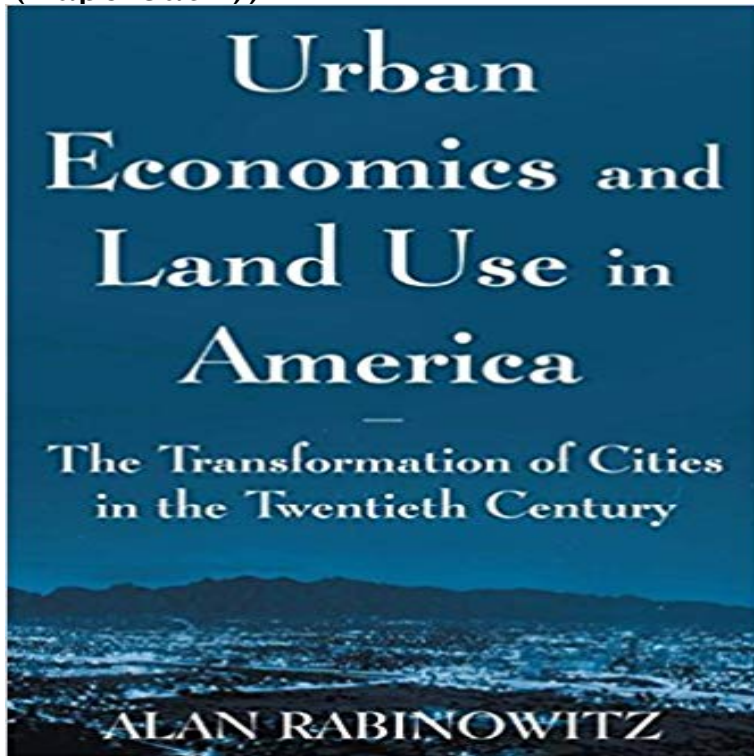


Urban Economics and Land Use in America: The Transformation of Cities in the Twentieth Century (Cities and Contemporary Society (Paperback))
